**Education and Awareness:**  
United to End Genocide educates the public about crises - such as Sudan, Syria and D.R. Congo - where innocent civilians' lives are threatened by potential mass atrocity or violence. We provide timely information and materials to coalition partners, student chapters, and activist groups nationwide, and communicate regularly with thousands of online activists and supporters. We also draw attention to crises by regularly communicating with the media to help keep Darfur, South Sudan, Syria and other conflict areas in the news, and we provide resources and support to members of survivor and Disapora communities worldwide to make sure their voices are heard by political leaders and the media.

**Advocacy:**  
United to End Genocide provides training, tools, and resources to grassroots activists worldwide who are dedicated to increasing public awareness about crisis situations and urging political leaders to take action to promote peace and protection of innocent civilians. We assist this broad and diverse anti-genocide movement in sponsoring public events such as rallies and press conferences, writing letters to the editors of local papers, and calling and emailing elected officials, among other activities. We provide activists with regular policy updates, materials such as brochures and posters, and staff support, as well as occasional small grants to assist them in undertaking advocacy activities.

**Policy and Government Relations:**  
United to End Genocide works to ensure that elected leaders support policies helpful to the people of genocide or mass atrocities worldwide. We have helped develop and advocate for policies that support deployment of peacekeeping forces in Darfur and provide U.S. funding for humanitarian support. We also raised awareness among policymakers of how violence against women is used as a weapon of genocide and mass atrocity. We engage with the UN, other international bodies, and foreign governments to urge action to end crises threatening innocent civilians' lives. We work with an array of partner organizations in Europe, Africa and the Middle East, and we provide support and training to civil society groups.
